HK Express Travel Insurance Lucky Draw Promotion Terms and Conditions

(A) General Terms and Conditions

- 1. The HK Express Travel Insurance Lucky Draw Promotion (the "Lucky Draw" or the "Promotion") is offered by AXA General Insurance Hong Kong Limited ("AXA") from 00:00 on 24 October 2025 to 23:59 on 23 January 2026 (Hong Kong time) (the "Promotion Period") and is subject to the Terms and Conditions stipulated in Sections (A) General Terms and Conditions and (B) Terms and Conditions of the Lucky Draw herein (the "Terms and Conditions").
- 2. The Promotion is applicable to customers who apply for a HK Express Travel Insurance Single Journey ("Single Journey Policy") and/or a HK Express Travel Insurance Annual Cover policy (Annual Cover Policy") (together "Eligible Policy") online during the Promotion Period ("Eligible Customers").
 - For clarity, an Eligible Customer need not to be one of the insured persons or the policyholders under an Eligible Policy but must be the applicant of the Eligible Policy.
- 3. All insurance applications are subject to the final approval by AXA.
- 4. All times and dates related to the Promotion are subject to the record of AXA's server.
- 5. AXA will not be responsible for any delays, errors, or inability to purchase the insurance online due to technical issues related to computers or the internet.
- 6. The Lucky Draw prizes cannot be exchanged to cash, and are non-reroutable, non-replaceable, non-transferrable and non-returnable.
- 7. The Lucky Draw prizes cannot be used in conjunction with other HK Express' vouchers or inflight promotion.
- 8. The Winner (as defined below) is responsible for obtaining a valid visa and fulfilling the entry requirements for the destination, if necessary.
- 9. The Winner is responsible for any applicable taxes, surcharges and other fees in relation to the Lucky Draw prizes.

- 11. By redeeming the Lucky Draw prizes, the Winner agrees that no claim shall be asserted against HK Express, its directors, officers, employees or agents relating to any and all losses or injuries (including special, indirect and consequential losses), damages, rights, claims and actions of any kind in connection with the voucher and any promotion thereof, including without limitation, personal injuries, death and property damage.
- 12. The Winner who fails to board the flight will be treated as forfeiting the Lucky Draw prizes. Under such circumstances, rebooking is not allowed.
- 13. In case of any dispute arising from the Promotion, the decision of AXA shall be final and conclusive.
- 14. No person other than the Eligible Customers, AXA will have any right under the Contracts (Rights of Third Parties) Ordinance (Cap. 623 of the Laws of Hong Kong SAR) to enforce or enjoy the benefit of any of the provisions of the general terms and conditions in both section (A) and section (B).
- 15. The invalidity, illegality or unenforceability of any of these Terms and Conditions shall not affect the remainder of these Terms and Conditions, which shall remain in full force and effect.

- 16. The Terms and Conditions are governed by and construed in accordance with the Laws of Hong Kong SAR.
- 17. If there is any inconsistency or conflict between the English version and the Chinese version of the Terms and Conditions, the English version shall prevail.

(B) Terms and Conditions of the Lucky Draw

1. There will be three rounds of Lucky Draw. The eligibility for entering into each round of the Lucky Draw and the key dates are specified in the table below:

The result will be published in AM730 and The Standard on the date specified.

2. Eligible Customers will **be automatically entered** into a specific round of the Lucky Draw if they apply for an Eligible Policy during the relevant period of that round, without the need for registration.

Customers' eligibility for entering into each round of the Lucky Draw will not be affected by whether they won a prize in the other rounds.

For clarity:

- Eligibility for entry into each round of the Lucky Draw depends on application time of the Eligible Policy, rather than the Period of Insurance.
- Eligible Customers who qualify for the First Round are **not automatically** eligible for the Second or Third Round. Similarly, Eligible Customers who qualify for the Second Round are **not automatically** eligible for the Third Round.
- Eligible Customers who won a prize in the First or Second Round may still be eligible for subsequent rounds, provided they apply for an Eligible Policy during the relevant period.
